MINUTE RECORD CITY OF WEEPING WATER PUBLIC HEARINGS/MONTHLY MEETING MAY 16, 2022

Mayor Michael Barrett called the monthly meeting of the Weeping Water City Council to order at 6:00 p.m. with the following members of the council answering roll: Lawrence Mozena, Sharon Heneger, Kelly Nutter and Michael Kindle. Notice of the monthly meeting was given in advance thereof by publication in the April 28, 2022 edition of the Plattsmouth Journal. The posted location of the Open Meetings Act was noted by the Mayor and a copy of all meeting materials was made available with the city clerk.

Notice of the public hearing to hear support, opposition, criticism, suggestions or observations of the public regarding adoption of an ordinance to amend Article 5, Section 4, entitled "Required improvements, street grading and construction" and Article 5, Section 9 entitled "Required improvements, sanitary sewer" of the subdivision regulations of the zoning ordinance was given in advance thereof by publication in the April 28, 2022 edition of the Plattsmouth Journal as well as being posted in three public places in the city. Mayor Michael Barrett opened the Public Hearing at 6:00 p.m. There being no public comment, the Mayor closed the public hearing at 6:02 p.m.

Notice of the public hearing to hear support, opposition, criticism, suggestions or observations of the public regarding the final plat for the development known as Vogler 3rd Addition was given in advance thereof by publication in the April 28, 2022 edition of the Plattsmouth Journal as well as being posted in three public places in the city. Mayor Michael Barrett opened the Public Hearing at 6:02 p.m. There being no public comment, the Mayor closed the public hearing at 6:03 p.m.

Notice of the public hearing to hear support, opposition, criticism, suggestions or observations of the public regarding the proposed rezoning of a tract of land in the Vogler 3rd Addition from Agricultural/Mining District (AG/M) to Medium Density Residential District (R-2) was given in advance thereof by publication in the April 28, 2022 edition of the Plattsmouth Journal as well as being posted in three public places in the city. Mayor Michael Barrett opened the Public Hearing at 6:03 p.m. There being no public comment, the Mayor closed the public hearing at 6:04 p.m.

Motion by Nutter, seconded by Kindle to approve the April 18, 2022 meeting minutes as prepared. On roll call those voting aye: Mozena, Heneger, Nutter and Kindle. Voting nay: None. Motion carried.

Monthly Reports: Fire-10 calls for the month. Motion by Heneger, seconded by Nutter to approve Zachary Fiala to the Fire Department. On roll call those voting aye: Mozena, Heneger, Nutter and Kindle. Voting nay: None. Motion carried. It was noted that there will be six members attending fire school this year. Rescue Department-Motion by Kindle, seconded by Heneger to approve a new contract for the Medical Director, Dr. Ernst, effective July 2022. On roll call those voting aye: Mozena, Heneger, Nutter and Kindle. Voting nay: None. Motion

carried. The Maintenance Report was presented by Jeff Buffington noting that some bank stabilization work needs to be completed on the lakes at the campground. Water/Wastewater Report-Items discussed were getting gas line to treatment plant for generator and lining of Well #1.

Motion by Heneger, seconded by Nutter to approve starting wage of \$10.00/hour for new summer employees plus \$.25 for returning employees. Heneger and Nutter withdraw motions and amend it to read \$11/hour. On roll call those voting aye: Mozena, Heneger, Nutter and Kindle. Nay: none. Motion carried.

Andrew Willis with Cline Williams Law Firm gave a presentation to the council regarding Tax Increment Financing (TIF) and how it works. The council was favorable to the idea. An ordinance to form a CDA Group, which is the first step in using TIF, will be presented at the June meeting.

Preliminary budget planning was discussed and will continue to be pursued.

Information regarding the Annual Audit Report was presented for council review.
